

Canadian University Graduate Transfer Agreement

Registered U of T graduate students wishing to study at an Ontario university must complete the Ontario Visiting Graduate Student (OVGS) agreement.

The Canadian University Graduate Transfer Agreement (CUGTA) permits a registered student in good academic standing to take a limited number of degree program course requirements at a Canadian Association for Graduate Studies (CAGS) member university without completing further admission formalities. The student is classified as a non-degree student at the host university.

Graduate course(s) taken through CUGTA must be requirements of the U of T degree program, and must not be available at U of T. Normally graduate students should not participate in CUGTA in their final year unless the official grade will be received by the SGS final grade and degree recommendation submission deadlines (refer to the SGS Calendar).

CUGTA graduate students will pay tuition for the course(s) concerned and applicable incidental fees at the host institution. If the host declines to accept tuition fees, this paragraph should be crossed out and initialled by the signing authority from Graduate Studies, in which case U of T will charge these fees.

Upon successful completion of the course(s), it is the student's responsibility to arrange for a transcript be sent directly to the U of T graduate unit. The student must also complete a transfer credit and/or course exemption form. Transfer credit will be limited to one full course (1.0 FCE) or 25% of the program course requirements, whichever is greater. A minimum grade equivalent to the U of T grade of B- must be obtained at the host university in order for a course to be considered for graduate transfer credit.
