

Graduate Exchange Agreement

The Graduate Exchange Agreement (GEA) is recognized by the School of Graduate Studies, U of T and has established authorization for graduate course study requests at **McGill University**, **Université de Montréal**, and **University of British Columbia**.

Graduate course(s) taken through GEA are subject to the regulations and deadlines of the host institution. These course(s) must be requirements of the U of T degree program, and must not be available at U of T. Normally graduate students should not participate in GEA in their final year unless the official grade will be received by the SGS final grade and degree recommendation submission deadlines (refer to the SGS Calendar). The graduate student pays tuition fees at U of T as per normal and is classified as a non-degree student at the host university. No tuition fees will be assessed by the host institution; however, applicable incidental fees will be charged.

Upon successful completion of the course(s), it is the student's responsibility to arrange that a transcript be sent directly to the Student Academic Services Office, School of Graduate Studies, U of T. Transfer credit will be limited to one full course (1.0 FCE) or 25% of the program course requirements, whichever is greater. A minimum grade equivalent to the U of T grade of B- must be obtained at the host university in order for a course to be considered for graduate transfer credit.
